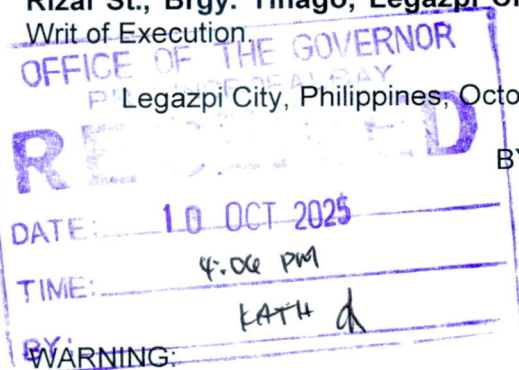
**NOTICE OF SHERIFF'S SALE**
