EN BANC RESOLUTION NO. 05-23
(Series of 2023)

WHEREAS, in view of Article 221 of the Labor Code of the Philippines, as amended, the Commission may provide as many Labor Arbiters as may be necessary for its effective and efficient operation;

WHEREAS, fifty-five percent (55%) of all cases filed in the Regional Arbitration Branches (RABs) originate from the NCR Arbitration Branch (NCRAB), hence, majority of the salas or offices of the Labor Arbiter are stationed in the NCR Arbitration Branch;

WHEREAS, to properly monitor the raffling, assignment and transfer of cases within the NCR Arbitration Branch, there is a need to provide a specific number of each sala or office of the Labor Arbiter;

WHEREAS, to maintain independence and impartiality, and obviate the association of the name of the Labor Arbiter, the salas or offices of the Labor Arbiter shall be identified based on the specific number assigned;

WHEREFORE, RESOLVED AS IT IS HEREBY RESOLVED, the Commission *En Banc* authorizes the Chairman to:

- (a) Provide specific number of all salas or offices of the Labor Arbiter in the NCR Arbitration Branch (NCRAB) in numerical order; and
- (b) Designate incumbent NCR Labor Arbiters in the respective arbitration branch number.


