WHEREAS, the NLRC Bids and Awards Committee (BAC), in its BAC Resolution No. 2022-11-01, resolved to "DECLARE the bid of LBC Express Inc. as the Lowest Calculated and Responsive Bid for the Procurement of Courier Services FY 2023" and to "RECOMMEND to Chairman Gerardo C.
