AWARD OF CONTRACT AND DECLARATION OF PLDT INC. AS HAVING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) FOR THE PROCUREMENT OF SUPPLY, INSTALLATION, COMMISSIONING AND TESTING OF INTERNET SERVICES (DIRECT INTERNET)

WHEREAS, the project "**PROCUREMENT OF SUPPLY, INSTALLATION, COMMISSIONING AND TESTING OF INTERNET SERVICES (1-lot Direct and 1-lot Back-up)**" is included in the approved Indicative Annual Procurement Plan 2021 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Two Million Pesos (Php2,000,000.00)**;

WHEREAS, the Procurement of Supply, Installation, Commissioning and Testing of Internet Services (**Direct Internet**) was advertised with an ABC of Php **1,800,000.00** while the Procurement of Supply, Installation, Commissioning and Testing of Internet Services (**Back-up Internet**) was advertised with an ABC of Php **200,000.00**;

WHEREAS, the submission and opening of bids for the Procurement of Supply, Installation, Commissioning and Testing of Internet Services (Direct Internet) was conducted on 16 December 2020 and participated in by PLDT Inc.;

WHEREAS, on the said date the Committee pronounced PLDT Inc. as the Single Calculated Bidder and directed the BAC- Technical Working Group (BAC-TWG) to conduct Post-Qualification Process on the bid of PLDT Inc.¹;

WHEREAS, the BAC-TWG submitted its Post-Qualification Report on 28 December 2020 with the following findings:²

Nograles the **AWARD** of contract to PLDT Inc.




