**DECLARATION OF TELCOM LIVE CONTENT INC. AS HAVING THE
LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR THE
PROCUREMENT OF CLOUD SERVICES SUBSCRIPTION, WEB
HOSTING WITH BACK-UP SERVER AND MAINTENANCE SERVICES FY
2022**

WHEREAS, the project "**PROCUREMENT OF CLOUD SERVICES SUBSCRIPTION, WEB HOSTING WITH BACK-UP SERVER AND MAINTENANCE SERVICES FY 2022**" is included in the approved Indicative Annual Procurement Plan 2022 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Two Million Pesos (Php 2,000,000.00)**;

WHEREAS, the submission and opening of bids was conducted on 20 October 2021 and participated in by **Moodlearning Inc. and Telcom Live Content Inc.**;

WHEREAS, on the said date the Committee pronounced **Telcom Live Content Inc.**; as the Lowest Calculated Bidder and directed the BAC- Technical Working Group (BAC-TWG) to conduct Post-Qualification Process on the bid of **Telcom Live Content Inc.**¹;

WHEREAS, the BAC-TWG submitted its Post-Qualification Report on 10 November 2021 with the following findings:²

RESOLVED FURTHER, to **RECOMMEND** to Chairman Gerardo C. Nograles the **AWARD** of contract to **Telcom Live Content Inc.** subject to approval of the General Appropriations Act FY 2022.


