NATIONAL LABOR RELATIONS COMMISSION with address at PPSTA Bldg. 5, Banawe cor. P. Florentino Sts., Quezon City herein represented by **HON. GERARDO C. NOGRALES**, Chairman, NLRC, and hereinafter referred to as the "Procuring Entity",

-and-

The **TRIPLE 7 MANPOWER SERVICES, INC.** with address at G/F, Cavite Coliseum, Aguinaldo Hi-way, Bacoor City Cavite herein represented by its President, **MR. LAMBERTO G. MERCADO**, and hereinafter referred to as the "Supplier"; collectively, the "Parties".

WHEREAS, the Procuring Entity invited Bids for the **Procurement of Janitorial Services for FY 2019 (August-December)** with an Approved Budget for the Contract (ABC) in the sum of ONE MILLION SIX HUNDRED SEVENTEEN THOUSAND FIVE HUNDRED PESOS (Php 1,617,500.00) inclusive of twelve percent (12%) Valued-Added Tax and other applicable Philippine government taxes;

WHEREAS, the Procuring Entity invited Bids and has accepted a Bid by the Supplier for the **Procurement of Janitorial Services for FY 2019 (August to December)** in the sum of **One Million Two Hundred Forty Seven Thousand Nine Hundred Seventy Four Pesos and 70/100 (P1,247,974.70)**.

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

1. In this CONTRACT, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - (c) the Supplemental Bid Bulletin no. 01 Series of 2019;
 - (d) the NLRC Bids and Awards Committee (BAC) Resolution No. 05-01, s. 2019;
 - (e) the Procuring Entity's Notification of Award; and
 - (f) the Procuring Entity's Notice to Proceed.


