**DECLARATION OF FAILURE OF BIDDING FOR THE PROCUREMENT OF
TRANSPORTATION EQUIPMENT [LOT 1] FY 2024**

WHEREAS, the project "**Procurement of Transportation Equipment FY 2024**" is included in the approved Indicative Annual Procurement Plan 2024 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Twenty-Six Million Six Hundred Fifty Thousand Pesos (Php26,650,000.00)**, with details as follows:

- a. Lot 1 – **Procurement of 1-unit Van Transportation Equipment FY 2024**, the sum of *One Million Four Hundred Fifty Thousand Pesos (Php 1,450,000.00)*; and
- b. Lot 2 – **Procurement of 18-units Sports Utility Vehicles/Multi-purpose Vehicles Transportation Equipment FY 2024**, the sum of *Twenty-Five Million Two Hundred Thousand Pesos (Php 25,200,000.00)*;

WHEREAS, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) website and NLRC website from 18 October 2023 to 8 November 2023;

WHEREAS, the Pre-Bid Conference held on 27 October 2023 was attended by Isuzu Pagbilao, Toyota, Quezon Avenue, Toyota, Fairview, Toyota Commonwealth and SFM Sales Corp;

WHEREAS, during the scheduled submission and opening of bids on 8 November 2023, no bid was received for Lot 1;


WHEREAS, Section 35.1 (a), Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A) No. 9184 provides for the authority of the BAC to declare a failure of bidding when no bids are received;

WHEREAS, as a result of the failure of bids, the end-user is instructed to conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2, Rule X of the 2016 RIRR of R.A. 9184;

NOW, WHEREFORE, in consideration of the foregoing, the Committee hereby **RESOLVES TO DECLARE** the First Failure of Bidding for the project "**Procurement of Transportation Equipment [LOT 1] FY 2024 [PB 05-2024]**" pursuant to Section 35.1 of the 2016 RIRR of R.A. 9184.


