



Contract for the Procurement of Transportation Equipment FY 2024 (LOT 2)

THIS CONTRACT made on the _____ day of JAN 22 2024 2024 in QUEZON CITY,
Philippines, by and between:

NATIONAL LABOR RELATIONS COMMISSION with office address at Ben-Lor I.T. Center, 1184, Quezon Avenue, Quezon City, herein represented by **HON. GRACE E. MANIQUIZ-TAN**, Chairperson, NLRC, (hereinafter called "the Procuring Entity"),

-and-

TOYOTA FAIRVIEW, INC. with office address at Neopolitan Business Park, Corner Mindanao Avenue, Quezon City, herein represented by its Marketing Professional, **MS. ANGENETTE A. GAN**, (hereinafter called "the Supplier");

WHEREAS, the Procuring Entity invited Bids for the **Procurement of Transportation Equipment FY 2024 (LOT 2)** with an Approved Budget for the Contract (ABC) in the sum of **TWENTY-FIVE MILLION TWO HUNDRED THOUSAND PESOS** (Php25,200,000.00) inclusive of twelve percent (12%) Valued-Added Tax and other applicable Philippine government taxes;

WHEREAS, the Procuring Entity invited Bids, and has accepted a Bid by the Supplier for the **Procurement of Transportation Equipment FY 2024 (LOT 2)** in the sum of **TWENTY-THREE MILLION THREE HUNDRED NINETY-FOUR THOUSAND SIX HUNDRED THIRTY-SIX PESOS ONLY** (Php23,394,636.00).

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Contract Agreement, viz.:
 - A) Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract;
 - iv. NLRC Bids and Awards Committee (BAC) Resolution No. 2023-11-10 and
 - v. Supplemental or Bid Bulletins, if any
 - B) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

C) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

D) Performance Security;

E) Notice of Award of Contract; and the Bidder's *conforme* thereto; and

F) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **TWENTY-THREE MILLION THREE HUNDRED NINETY-FOUR THOUSAND SIX HUNDRED THIRTY-SIX PESOS ONLY** (Php23,394,636.00) or such other sums as may be ascertained, the Supplier agrees to cause the delivery of the Eighteen (18) Units Sports Utility Vehicles (SUVs) /Multi-purpose Vehicles (MPVs).
4. The Supplier agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


