**DECLARATION OF FIRST FAILURE OF BIDDING FOR THE
PROCUREMENT OF CLOUD SERVICES SUBSCRIPTION, WEB HOSTING
WITH BACK-UP SERVER AND MAINTENANCE REQUIREMENTS FOR FY
2025**

WHEREAS, the project “**Procurement of Cloud Services Subscription, Web Hosting with Back-Up Server and Maintenance Requirements for FY 2025 (PB 03-2025 EPA)**” is included in the approved Indicative Annual Procurement Plan for FY 2025 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Five Million Pesos (Php 5,000,000.00)**;

WHEREAS, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) website and NLRC website from 29 October 2024 to 18 November 2024;

WHEREAS, the Pre-Bid Conference held on 06 November 2024 was attended by First Data Corp., CBSAC, and Software One;

WHEREAS, during the scheduled submission and opening of bids on 18 November 2024, no bid was received;

WHEREAS, Section 35.1 (a), Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184 provides for the authority of the Bids and Awards Committee (BAC) to declare a failure of bidding when no bids are received;

WHEREAS, as a result of the failure of bidding, the end-user is instructed to conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2, Rule X of the 2016 RIRR of R.A. No. 9184;

NOW, WHEREFORE, in consideration of the foregoing, the BAC hereby **RESOLVES TO DECLARE** the First Failure of Bidding for the project “**Procurement of Cloud Services Subscription, Web Hosting with**

Back-Up Server and Maintenance Requirements for FY 2025 (PB 03-2025 EPA)" pursuant to Section 35.1 of the 2016 RIRR of R.A. No. 9184.
