**DECLARATION OF FIRST FAILURE OF BIDDING FOR THE
PROCUREMENT OF COURIER SERVICES FY 2024**

WHEREAS, the project "**Procurement of Courier Services FY 2024**" is included in the approved Indicative Annual Procurement Plan 2024 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of ***Eleven Million Five Hundred Thousand Pesos (Php 11,500,000.00)***.

WHEREAS, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) website and NLRC website from November 7, 2023 to November 28, 2023;

WHEREAS, the Pre-Bid Conference held 15 November 2023 was attended by LIBCAP Super Express Corporation, GO21, 2GO Express, and Intertraffic Transport Corp.;

WHEREAS, during the scheduled submission and opening of bids on 28 November 2023, LIBCAP Super Express Corporation participated as the lone bidder;

WHEREAS, in a Resolution dated 28 November 2023, the Bids and Awards Committee (BAC) declared LIBCAP Super Express Corporation as the Single Calculated Bid and directed the BAC Technical Working Group (BAC-TWG) to conduct Post-Qualification Process;

WHEREAS, in the Post-Qualification Report of the BAC-TWG dated 07 December 2023, the BAC-TWG recommended the following, to wit:

1. *To declare the Company to be post-disqualified for failure to submit the post-qualification requirements on time in accordance with Section 34.2 of the 2016 Revised IRR of RA No. 9184; and*

2. To declare the bidding for the Procurement of Courier Services for FY 2024 a "failure" pursuant to Section 35.1 (c) of the 2016 Revised IRR of RA 9184


WHEREAS, Section 35.1 (c), Rule X of the 2016 Revised IRR of RA No. 9184 provides for the authority of the BAC to declare a failure of bidding when all bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation;

WHEREAS, as a result of the failure of bids, the end-user is instructed to conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2, Rule X of the 2016 RIRR of R.A. 9184;

NOW, WHEREFORE, in consideration of the foregoing, the Committee hereby **RESOLVES TO DECLARE** the First Failure of Bidding for the project "**Procurement of Courier Services FY 2024 [PB 06-2024]**" pursuant to Section 35.1 (c) of the 2016 RIRR of R.A. 9184.


