**DECLARATION OF REMAX INTERNATIONAL, INC. AS THE SINGLE
CALCULATED AND RESPONSIVE BID (SCRB) FOR THE SUPPLY AND
DELIVERY OF INFORMATION COMMUNICATIONS TECHNOLOGY
(ICT) EQUIPMENT FOR FY 2025 AND RECOMMENDATION TO AWARD
THE CONTRACT**

WHEREAS, the project **"Supply and Delivery of Information and Communications Technology (ICT) Equipment for FY 2025"** is included in the approved Indicative Annual Procurement Plan for FY 2025 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Thirty One Million One Hundred Thousand Pesos (P31,100,000.00)** under **four (4) lots**, with details as follows:

- a. Lot 1: **Procurement of 50-units Training Laptop Computers**, in the sum of **Two Million Five Hundred Thousand Pesos (P2,500,000.00)**;
- b. Lot 2: **Procurement of 22-units Multimedia Laptop Computers**, in the sum of **Two Million Two Hundred Thousand Pesos (P2,200,000.00)**;
- c. Lot 3: **Procurement of 120-units Productivity Desktop Computers**, in the sum of **Seven Million Two Hundred Thousand Pesos (P7,200,000.00)**; and
- d. Lot 4: **Procurement of 192-units AI Desktop Computers**, in the sum of **Nineteen Million Two Hundred Thousand Pesos Only (P19,200,000.00)**;

WHEREAS, the NLRC advertised the Invitation to Bid for the abovementioned project through the Philippine Government E-Procurement System (PhilGEPS) and NLRC website from 21 November 2024 to 11 December 2024;

WHEREAS, in response to the advertisements, **Remax International, Inc.** submitted its eligibility documents as the lone bidder for all four (4) lots on 11 December 2024, which was the deadline for the Submission and Opening of Eligibility Documents;

WHEREAS, after evaluation and deliberation, the Bids and Awards Committee (BAC) pronounced **Remax International, Inc.** as the Single Calculated Bid, with the following bid prices¹:

WHEREAS, after examination, validation, and verification of all the legal, technical, and financial documents submitted by **Remax International, Inc.**, the BAC, together with the TWG, determined, pursuant to the Post-Qualification Report dated 18 December 2024², that the bid submitted by **Remax International, Inc.** passed the criteria for post-qualification and was found to be responsive to the requirements of the project.


NOW, WHEREFORE, the BAC **RESOLVES** as it hereby **RESOLVED** to:
