**DECLARATION OF TRIPLE 7 MANPOWER SERVICES INC. AS  
HAVING THE SINGLE CALCULATED and RESPONSIVE BID (SCRB)  
FOR THE PROCUREMENT OF JANITORIAL SERVICES FY 2023  
AND RECOMMENDATION TO AWARD THE CONTRACT TO TRIPLE  
7 MANPOWER SERVICES INC.**

**WHEREAS**, the project "**Procurement of Janitorial Services FY 2023**" is included in the approved Indicative Annual Procurement Plan 2023 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Four Million Four Hundred Sixty Eight Pesos (Php 4,468,000.00)**

**WHEREAS**, the submission and opening of bids was conducted on 5 December 2022 and participated in by Triple 7 Manpower Services Inc.;

**WHEREAS**, on the said date the Committee pronounced **Triple 7 Manpower Services Inc.** as the Single Calculated Bidder and directed the BAC-Technical Working Group (BAC-TWG) to conduct Post-Qualification Process on the bid of Triple 7 Manpower Services Inc.<sup>1</sup>;

**WHEREAS**, during the meeting, the BAC-TWG presented its Post-Qualification Report dated 13 December 2022 with the following findings:<sup>2</sup>

*"Based on the foregoing, the Company **passed the legal, technical and financial requirements for the post qualification process in the Procurement of Janitorial Services FY 2023.**"*




