DECLARING 2nd FAILURE OF BIDDING FOR THE PROCUREMENT OF I.T. EQUIPMENT (DESKTOP COMPUTERS) AND TO PROCEED WITH NEGOTIATED PROCUREMENT

WHEREAS, the project “**Procurement of I.T. Equipment (Forty (40) Desktop Computers)**” is included in the Indicative Annual Procurement Plan 2020 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) **Two Million One Hundred Thousand Pesos** (₱ 2, 100,000.00);

WHEREAS, the National Labor Relations Commission (NLRC) advertised the Invitation to Bid for the abovementioned project with an ABC of **Two Million One Hundred Thousand Pesos** (₱ 2,100,000.00) at the Philippine Government E-Procurement System (PhilGeps), NLRC Website and conspicuous places at the NLRC premises from 05 December 2019 to 23 December 2019;

WHEREAS, the Pre-Bid Conference held on 11 December 2019 was attended by Advance Solutions Inc.;

WHEREAS, no bids were received on time prior to the Bid Opening scheduled on 23 December 2019;

WHEREAS, under Section 35.1 of the RIRR of R.A. 9184, the BAC shall declared the bidding a failure when no bids were received;

WHEREAS, the BAC declared the 2nd Bidding for the Project as “**FAILED**” and recommended for the approval of the Head of Procuring Entity (HoPE) to proceed with the Negotiated Procurement as per Section 53.1 of the 2016 Revised Implementing Rules and Regulations of RA 9184.



1. To declare the **2nd Failure of Bidding** for the Project and:




