**APPROVAL OF THE PROCUREMENT MONITORING REPORT FOR THE
SECOND SEMESTER OF FY 2024**

WHEREAS, under Section 12.2 of the Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act," the Bids and Awards Committee (BAC) shall be responsible for ensuring that the Procuring Entity abides by the standards set forth by the Act and this IRR, and it shall prepare a Procurement Monitoring Report (PMR) in the form prescribed by the Government Procurement Policy Board (GPPB);

WHEREAS, the same provision states that the PMR shall cover all procurement activities specified in the Annual Procurement Plan (APP), whether ongoing or completed, from the holding of the pre-procurement conference to the issuance of notice of award and the approval of the contract, including the standard and actual time for each major procurement activity;

WHEREAS, during the National Labor Relations Commission (NLRC) BAC Meeting held on 14 January 2025, the BAC Secretariat, together with the representatives from the Management and Administrative Department, presented the PMR for the Second Semester of FY 2024;

WHEREAS, based on the report, procurement activities for FY 2024 through Public Bidding were conducted, and all procurement activities made through the Alternative Modes of Procurement were undertaken by the NLRC Administrative


Department (General Administrative Services) under a valid delegation by the NLRC BAC¹;

WHEREAS, all procurement documents to support the validity of the procurement activities conducted under the Alternative Modes of Procurement were duly presented and are under the custody and control of the NLRC Administrative Department (General Administrative Services);


