WHEREAS, the Procuring Entity invited Bids for the **Procurement of Courier Services for FY 2021** with an Approved Budget for the Contract (ABC) in the sum of **EIGHT MILLION SIX HUNDRED THOUSAND PESOS** (Php 8,600,000.00) inclusive of twelve percent (12%) Valued-Added Tax and other applicable Philippine government taxes;


WHEREAS, the Procuring Entity invited Bids and has accepted a Bid by the Supplier for the **Procurement of Courier Services for FY 2021** in the sum of **SEVEN MILLION FIVE HUNDRED THIRTY-FIVE THOUSAND FIVE HUNDRED PESOS ONLY** (Php7,535,500.00)

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

1. In this CONTRACT, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this CONTRACT, viz.:
 - a) Bidding Documents;
 - b) Winning bidder's bid, including the Technical and Financial Proposal, and all other documents/statements submitted by the Supplier;
 - c) Technical Specifications and Terms of Reference;
 - d) General Conditions of the Contract (GCC);
 - e) Special Conditions of the Contract (SCC);

The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.


