**DECLARATION OF THE BID OF LBC EXPRESS, INC. AS THE
LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR THE
PROCUREMENT OF COURIER SERVICES FY 2023 AND
RECOMMENDATION TO AWARD THE CONTRACT TO LBC
EXPRESS INC.**

WHEREAS, the project "**PROCUREMENT OF COURIER SERVICES FY 2022**" is included in the approved Indicative Annual Procurement Plan 2022 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Eleven Million Seven Hundred Thirty-Nine Thousand Pesos (Php11,739,000.00)**;

WHEREAS, the submission and opening of bids was conducted on 25 October 2022 and participated in by **Airspeed International Corporation and LBC Express Inc.**;

WHEREAS, on the said date the Committee pronounced LBC Express Inc. as the Lowest Calculated Bidder and directed the BAC- Technical Working Group (BAC-TWG) to conduct Post-Qualification Process on the bid of LBC Express Inc.¹;

WHEREAS, during the meeting, the BAC-TWG presented its Post-Qualification Report dated 07 November 2022 with the following findings:²

*"Based on the foregoing, the Company **passed the legal, technical and financial requirements for the post qualification process** in the Procurement of Courier Services FY 2023."*


