**DECLARATION OF JONECO TECH MARKETING CORP. HAVING
THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR
THE SUPPLY OF ICT EQUIPMENT FY 2024 (2ND BIDDING) – LOT
1 AND RECOMMENDATION TO AWARD THE CONTRACT**

WHEREAS, the project "**Supply of ICT Equipment FY 2024 (2nd Bidding)**" is included in the approved Indicative Annual Procurement Plan 2024 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Eleven Million Twenty Five Thousand Pesos Only (Php11,025,000.00)** under **two (2) lots**, with details as follows:

- a. Lot 1 – **Procurement of 54 Units Laptop Computers With Operating System and Office Productivity Suite for FY 2024**, the sum of **Two Million Seven Hundred Thousand Pesos Only (Php2,700,000.00)**, and
- b. Lot 2 – **Procurement of 185 Units Mid-Range Desktop Computers With Operating System and Office With Operating System and Office Productivity Suite for FY 2024**, the sum of **Eight Million Three Hundred Twenty Five Thousand Pesos Only (Php8,325,000.00)**;

WHEREAS, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) website and NLRC website from 29 February 2024 to 20 March 2024;

WHEREAS, in response to the advertisements, (1) Quartz Business Products Corporation, (2) Xitrix Computer Corporation, (3) Infoworx, Inc., and (4) Joneco Tech Marketing Corp. submitted their eligibility documents for Lot 1 on 20 March 2024, which was the deadline for the Submission and Opening of Eligibility Documents;


WHEREAS, after deliberation, the BAC pronounced **Joneco Tech Marketing Corp.** as the Lowest Calculated Bidder for Lot 1, with a bid price of Two Million One Hundred Twenty Seven Thousand Six Hundred Pesos (Php2,127,600.00)¹ and directed the Technical Working Group (TWG) to conduct a Post-Qualification Process on the said bidder;

WHEREAS, after examination, validation, and verification of all the legal, technical, and financial documents submitted by Joneco Tech Marketing Corp. for Lot 1, the BAC, together with the TWG, determined, pursuant to its Post-Qualification Report dated April 1, 2024², that the bid submitted by Joneco Tech Marketing Corp. for the said lot passed the criteria for post-qualification and was found to be responsive to the requirements of the project.

NOW, WHEREFORE, in consideration of the foregoing, the BAC **RESOLVES** as it hereby **RESOLVED** to **DECLARE** the bid submitted by **JONECO TECH MARKETING CORP.** as the Lowest Calculated and Responsive Bid for the **SUPPLY OF ICT EQUIPMENT FY 2024 (2ND BIDDING) – LOT 1**, and to **RECOMMEND** the award of the contract.
