AWARD OF CONTRACT AND DECLARATION OF TELCOM LIVE CONTENT INC. AS HAVING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR THE PROCUREMENT OF CLOUD SERVICES SUBSCRIPTION, WEB HOSTING WITH BACK-UP SERVER AND MAINTENANCE SERVICES FY 2021

WHEREAS, the project "**Procurement of Cloud Services Subscription, Web Hosting with Back-up Server and Maintenance Services FY 2021**" is included in the approved Indicative Annual Procurement Plan 2021 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Two Million Four Hundred Thousand Pesos (Php2,400,000.00)**;

WHEREAS, the submission and opening of bids for the Procurement of Cloud Services Subscription, Web Hosting with Back-up Server and Maintenance Services FY 2021 was conducted on 15 December 2020 and participated in by three bidders namely, Telcom Live Content Inc., Moodlelearning Inc. and SVI Technologies Inc.;

WHEREAS, on the said date the Committee pronounced Telcom Live Content Inc. as the Lowest Calculated Bidder and directed the BAC- Technical Working Group (BAC-TWG) to conduct Post-Qualification Process on the bid of Telcom Live Content Inc.¹;

WHEREAS, the BAC-TWG submitted its Post-Qualification Report on 15 December 2020 with the following findings:²

Nograles the **AWARD** of contract to Telcom Live Content Inc.




