



Contract for the Procurement of ICT Software — 112 Units Windows Operating System Software Licenses for FY 2024 (LOT 3)

THIS CONTRACT made on the _____ day of _____ 2024 in _____ Philippines, by and between:

NATIONAL LABOR RELATIONS COMMISSION with office address at Ben-Lor I.T. Center, 1184, Quezon Avenue, Quezon City, herein represented by **HON. GRACE E. MANQUIZ-TAN**, Chairperson, NLRC, (hereinafter called "the Procuring Entity"),

-and-

REMAX INTERNATIONAL, INC. with office address at 18 United St., Brgy. Kapitolyo, Pasig City, herein represented by its Senior Account Manager, **MR. HOMER CORDERO**, (hereinafter called "the Supplier");

WHEREAS, the Procuring Entity invited Bids for the Procurement of ICT Software — 112 Units Windows Operating System Software Licenses for FY 2024 (LOT 3) with an Approved Budget for the Contract (ABC) in the sum of ONE MILLION SIX HUNDRED EIGHTY THOUSAND PESOS (Php1,680,000.00) inclusive of twelve percent (12%) Value-Added Tax and other applicable Philippine government taxes;

WHEREAS, the Procuring Entity invited Bids, and has accepted a Bid by the Supplier for the Procurement of ICT Software — 112 Units Windows Operating System Software Licenses for FY 2024 (LOT 3) in the sum of EIGHT HUNDRED SEVENTEEN THOUSAND SIX HUNDRED PESOS ONLY (Php817,600.00).

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Contract Agreement, viz.:

A) Philippine Bidding Documents (PBDs);

- i. Schedule of Requirements;
- ii. Technical Specifications;
- iii. General and Special Conditions of Contract;
- iv. NLRC Bids and Awards Committee (BAC) Resolution No. 2023-11-08 and
- v. Supplemental or Bid Bulletins, if any

B) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

E) Notice of Award of Contract; and the Bidder's *conforme* thereto; and

F) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **EIGHT HUNDRED SEVENTEEN THOUSAND SIX HUNDRED PESOS ONLY** (Php817,600.00) or such other sums as may be ascertained, the Supplier agrees to provide 112 Units Windows Operating System Software Licenses.
4. The Procuring Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
