**DECLARATION OF FIRST FAILURE OF BIDDING FOR THE  
PROCUREMENT OF CLOUD SERVICES SUBSCRIPTION, WEB HOSTING  
WITH BACK-UP SERVER AND MAINTENANCE REQUIREMENTS FOR FY  
2025**

**WHEREAS**, the project “**Procurement of Cloud Services Subscription, Web Hosting with Back-Up Server and Maintenance Requirements for FY 2025**” is included in the approved Indicative Annual Procurement Plan for FY 2025 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Five Million Pesos (P 5,000,000.00)**;

**WHEREAS**, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) and NLRC website from 29 October 2024 to 18 November 2024;

**WHEREAS**, the Pre-Bid Conference held on 6 November 2024 was attended by First Datacorp, CBSAC Enterprises, PLDT Enterprise, and Software One;

**WHEREAS**, during the scheduled submission and opening of bids on 18 November 2024, no bid was received;


**WHEREAS**, Section 35.1 (a), Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) OF Republic Act (R.A.) No. 9184 provides for the authority of the BAC to declare a failure of bidding when no bids are received;

**WHEREAS**, as a result of the failure of bidding, the end-user is instructed to conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2, Rule X of the 2016 RIRR of R.A. No. 9184.

**NOW, WHEREFORE**, the BAC **RESOLVES** as it hereby **RESOLVED** to **DECLARE** the **FIRST FAILURE OF BIDDING** for the project, “**PROCUREMENT OF CLOUD SERVICES SUBSCRIPTION, WEB HOSTING WITH BACK-UP SERVER AND MAINTENANCE REQUIREMENTS FOR FY 2025**” pursuant to Section 35.1 of the 2016 RIRR of R.A. No. 9184.


