**WHEREAS**, the Procuring Entity invited Bids and has accepted a Bid by the Supplier for the **Procurement of Janitorial Services for FY 2020** in the sum of **THREE MILLION TWO HUNDRED FORTY FOUR THOUSAND ONE HUNDRED FOURTEEN PESOS AND EIGHT CENTAVOS 08/100 (P3, 244,114.08)**.




