**DECLARATION OF REMAX INTERNATIONAL, INC. AS HAVING  
THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR  
THE PROCUREMENT OF ICT SOFTWARE FY 2024 – LOT 3 AND  
RECOMMENDATION TO AWARD THE CONTRACT**

**WHEREAS**, the project "Procurement of ICT Software FY 2024" is included in the approved Indicative Annual Procurement Plan 2024 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of *Six Million And Forty Thousand Pesos (Php 6,040,000.00)*, with details as follows:

- a. Lot 1 – Procurement of 224 Units Microsoft Office Productivity Suite Licenses for FY 2024, the sum of *Three Million and Three Hundred Sixty Thousand Pesos (Php 3,360,000.00)*;
- b. Lot 2 – Procurement of Next-Generation Firewall for NLRC Central Office for FY 2024, the sum of *One Million Pesos (Php 1,000,000.00)*; and
- c. Lot 3 – Procurement of 112 Units of Windows Operating System Software Licenses FY 2024, the sum of *One Million and Six Hundred Eighty Thousand Pesos (Php 1,680,000.00)*;

**WHEREAS**, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) website and NLRC website from 9 October 2023 to 31 October 2023;

**WHEREAS**, in response to the advertisements, (1) EGM Systems, (2) Questech Co., Inc., (3) DCI Int'l IT Solutions & Services Corp., (4) Remax International, Inc., and (5) HundredFold Trading Corp. submitted their eligibility documents on 31 October 2023, which was the deadline for the Submission and Opening of Eligibility Documents;

**WHEREAS**, during the Submission and Opening of Eligibility Documents, (1) Questech Co., Inc., (2) DCI Int'l Solutions & Services Corp., (3) Remax International, Inc., and (4) HundredFold Trading Corp.Inc. manifested their intent to bid for **Lot 3**;

**WHEREAS**, during the Submission and Opening of Eligibility Documents, (1) Questech Co., Inc., (2) DCI Int'l Solutions & Services Corp., and (3) Remax International, Inc. were declared as "PASSED" while HundredFold Trading Corp. was declared as "FAILED" for failure to provide any ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid, as required under Class "A" of the eligibility documents;

**WHEREAS**, after deliberation, the BAC pronounced Remax International, Inc. for Lot 3, with a bid price of Eight Hundred Seventeen Thousand Six Hundred Pesos (Php817,600.00)<sup>1</sup> and directed the Technical Working Group (TWG) to conduct a Post-Qualification Process on the said bidder;

**WHEREAS**, after examination, validation, and verification of all the legal, technical, and financial documents submitted by Remax International, Inc. for Lot 3, the BAC, together with the TWG, determined, pursuant to its Post-Qualification Report dated 13 November 2023<sup>2</sup>, that the bid submitted by Remax International, Inc. for the said lot passed the criteria for post-qualification and was found to be responsive to the requirements of the project.

**NOW, WHEREFORE**, in consideration of the foregoing, the BAC **RESOLVES** as it hereby **RESOLVED** to **DECLARE** the bid submitted by **REMAX INTERNATIONAL, INC.** as the Lowest Calculated and Responsive Bid for the **PROCUREMENT OF ICT SOFTWARE FY 2024 – LOT 3 (112 Units of Windows Operating System Software Licenses)**, and to **RECOMMEND** the award of the contract.


