**DECLARATION OF THE BID OF CONVERGE ICT SOLUTIONS INC.
AS THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB)
FOR THE PROCUREMENT OF SUPPLY, INSTALLATION,
COMMISSIONING, AND TESTING OF INTERNET SERVICES
(BACKUP INTERNET) FY 2023 AND RECOMMENDATION TO
AWARD THE CONTRACT TO CONVERGE ICT SOLUTIONS INC.**

WHEREAS, the project **“PROCUREMENT OF SUPPLY, INSTALLATION, COMMISSIONING AND TESTING OF INTERNET SERVICES FY 2023 (1-lot Direct and 1-lot Back-up)”** is included in the approved Indicative Annual Procurement Plan 2022 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of ***Two Million Pesos (Php2,000,000.00)***;

WHEREAS, the submission and opening of bids was conducted on 25 October 2022 and participated in by **Source Telecommunication Inc., Philippine Global Communications Inc., and Converge ICT;**

WHEREAS, on the said date the Committee pronounced **Converge ICT Solutions Inc.** as the Single Calculated Bidder and directed the BAC- Technical Working Group (BAC-TWG) to conduct Post-Qualification Process on the bid of **Converge ICT Solutions Inc.;**

WHEREAS, during the meeting, the BAC-TWG presented its Post-Qualification Report dated 21 November 2022 with the following findings:¹

*"Based on the foregoing, the Company **passed the legal, technical and financial requirements for the post qualification process** in the Procurement of Supply, Installation, Commissioning and Testing of Internet Services (Back up Internet) FY 2023"*

WHEREAS, during the meeting, the end-user representatives submitted their Inspection Report dated 07 November 2022 manifesting that **Converge ICT Solutions Inc.** meets the technical specifications required by the project.²

NOW WHEREFORE, in consideration of the foregoing, the Committee **RESOLVES** as it hereby **RESOLVED** to **APPROVE** the findings of the BAC-TWG and to **DECLARE** the bid of **Converge ICT Solutions Inc.** as the Single Calculated and Responsive Bid for the Procurement of Supply, Installation, Commissioning and Testing of Internet Services (Back up Internet) FY 2023;

RESOLVED FURTHER, to **RECOMMEND** to Chairman Gerardo C. Nograles the **AWARD** of contract to **Converge ICT Solutions Inc.** subject to approval of the General Appropriations Act FY 2023.


