RECOMMENDING APPROVAL OF THE 2026 NLRC INDICATIVE ANNUAL PROCUREMENT PLAN (NON-CSE)

WHEREAS, Section 7.1 of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 12009, or the “New Government Procurement Act”, provides that all procurement shall be undertaken with proper and sufficient planning and preparation to ensure sound procurement decisions, taking into consideration, among others, the needs of the Procuring Entity, relevance and appropriateness of the project, value for money, and associated risks;

WHEREAS, Section 7.8 of the IRR of R.A. No. 12009 provides that no government procurement shall be undertaken unless it is in accordance with the approved Indicative Annual Procurement Plan (APP) or final APP of the Procuring Entity, as the case may be;

WHEREAS, Section 7.7.1 of the IRR of R.A. No. 12009 provides that, in the preparation of the Indicative APP to support the agency budget proposal, the End-User or Implementing Units of the Procuring Entity shall formulate their respective Project Procurement Management Plans (PPMPs) covering their programs, activities, and projects (PAPs);

WHEREAS, on 15 September 2025, the Management and Administrative Department submitted the 2026 Consolidated Indicative PPMP with the corresponding allocated budget for each program, activity, and project¹;






