**DECLARATION OF FIRST FAILURE OF BIDDING FOR THE
PROCUREMENT OF CLOUD SERVICES SUBSCRIPTION, WEB
HOSTING WITH BACK-UP SERVER AND MAINTENANCE
REQUIREMENTS FOR FY 2024**

WHEREAS, the project "**Procurement of Cloud Services Subscription, Web Hosting with Back-Up Server and Maintenance Requirements for FY 2024 [PB 04-2024]**" is included in the approved Indicative Annual Procurement Plan 2024 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **One Million Pesos (Php 1,000,000.00)**;

WHEREAS, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) and NLRC Website from 13 October 2023 to 3 November 2023;

WHEREAS, the Pre-Bid Conference held on 20 October 2023 was attended by Yuicon Unlimited Concepts, Inc., Eastern Telecom Phils., Inc., My Creative Panda Web Design and Moodlearning, Inc.;

WHEREAS, during the scheduled submission and opening of bids on 3 November 2023, no bid was received;

WHEREAS, Section 35.1 (a), Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A) No. 9184 provides for the authority of the BAC to declare a failure of bidding when no bids are received;


WHEREAS, as a result of the failure of bidding, the end-user is instructed to conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2, Rule X of the 2016 RIRR of R.A. 9184;

NOW, WHEREFORE, in consideration of the foregoing, the Committee hereby **RESOLVES TO DECLARE** the First Failure of Bidding for the project "**Procurement of Cloud Services Subscription, Web Hosting with Back-Up**

Server and Maintenance Requirements for FY 2024 [PB 04-2024]" pursuant to Section 35.1 of the 2016 RIRR of R.A. 9184.


