**DECLARATION OF FIRST FAILURE OF BIDDING FOR THE
PROCUREMENT FOR THE REPAIR AND MAINTENANCE OF IT
EQUIPMENT AND SOFTWARE FY 2024**

WHEREAS, the project "**Procurement for the Repair and Maintenance of IT Equipment and Software FY 2024**" is included in the approved Indicative Annual Procurement Plan 2024 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **One Million One Hundred Fifty Five Thousand Pesos (Php 1,155,000.00)**, with details as follows:

- a. Lot 1: Procurement of Continuous Ink System Inkjet Printers for FY 2024**, the sum of **One Hundred Eighty Thousand Pesos (Php180,000.00)**;
- b. Lot 2: Procurement of Local Area Network Hardware for FY2024**, the sum of **Seven Hundred Twenty Thousand Pesos (Php720,000.00)** and
- c. Lot 3: Procurement of ICT Hardware Spare Parts and Maintenance Items for FY 2024** the sum of **Two Hundred Fifty Five Thousand Pesos (Php255,000.00)**.

WHEREAS, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) and NLRC Website from 22 November 2023 to 11 December 2023;

WHEREAS, during the Pre-Bid Conference on 29 November 2023, no bidders participated;

WHEREAS, during the scheduled submission and opening of bids on 11 December 2023, no bid was received;


WHEREAS, Section 35.1 (a), Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A) No. 9184 provides for the authority of the BAC to declare a failure of bidding when no bids are received;

WHEREAS, as a result of the failure of bids, the end-user is instructed to conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2, Rule X of the 2016 RIRR of R.A. 9184;

NOW, WHEREFORE, in consideration of the foregoing, the Committee hereby **RESOLVES TO DECLARE** the First Failure of Bidding for the project "**Procurement for the Repair and Maintenance of IT Equipment and Software FY 2024**" pursuant to Section 35.1 of the 2016 RIRR of R.A. 9184.


