**AWARD OF CONTRACT TO MOODLEARNING INC. FOR HAVING THE  
LOWEST CALCULATED AND RESPONSIVE BID FOR THE  
PROCUREMENT OF NLRC CLOUD SERVICES, WEB HOSTING WITH  
BACK-UP SERVER AND MAINTENANCE REQUIREMENTS CY 2020**

**WHEREAS**, the project “**Procurement of NLRC Cloud Services, Web Hosting with Back-up Server and Maintenance Requirements CY 2020**” is included in the approved Annual Procurement Plan 2020 with an Approved Budget for the Contract (ABC) of Two Million Four Hundred Thousand Pesos (₱ 2,400,000.00);

**WHEREAS**, the submission and opening of bids for the procurement of NLRC Cloud Services, Web Hosting with Back-up Server and Maintenance Requirements CY 2020 was conducted on 02 December 2019 and participated in by the following bidder, to wit:

**WHEREAS**, on the said date the Committee declared **Moodlearning Inc.** as the **Lowest Calculated Bidder** and directed the BAC TWG to conduct as Post Qualification on the bid of Moodlearning Inc.

**WHEREAS**, the BAC TWG submitted its Post Qualification Report on 12 December 2019 with the following findings: <sup>1</sup>

*“xxx the Company passed the legal, technical and financial requirements for the post qualification process in the Procurement of NLRC Cloud Services, Web Hosting with Back-up Server and Maintenance Requirements CY 2020.”*


