**DECLARATION OF THE BID OF 2GO EXPRESS, INC. AS THE

RECOMMENDATION TO AWARD THE CONTRACT TO 2GO

WHEREAS, the project "**PROCUREMENT OF COURIER SERVICES FY 2022**" is included in the approved Indicative Annual Procurement Plan 2022 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of ***Eleven Million Seven Hundred Thirty-Nine Thousand Pesos (Php11,739,000.00)***;

WHEREAS, the submission and opening of bids was conducted on 20 October 2021 and participated in by **2GO Express Inc., Airspeed International Corporation and LBC Express Inc.**;

WHEREAS, on the said date the Committee pronounced 2GO Express Inc. as the Lowest Calculated Bidder and directed the BAC- Technical Working Group (BAC-TWG) to conduct Post-Qualification Process on the bid of 2GO Express Inc.¹;

WHEREAS, during the meeting, the BAC-TWG presented its Post-Qualification Report dated 29 October 2021 with the following findings:²

*"Based on the foregoing, the Company **passed the legal, technical and financial requirements for the post qualification process in the Procurement of Courier Services FY 2022.**"*

NOW WHEREFORE, in consideration of the foregoing, the Committee **RESOLVES** as it hereby **RESOLVED** to **APPROVE** the findings of the TWG and to




