**AWARD OF CONTRACT TO TRIPLE 7 MANPOWER SERVICES, INC. FOR

WHEREAS, the project "**Procurement of Janitorial Services for FY 2020**" is included in the approved Annual Procurement Plan 2020 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of *Four Million Eighty Three Thousand Pesos (Php 4,083,000.00)*;

WHEREAS, the submission and opening of bids for the procurement of Security Services was conducted on 18 November 2019 and participated in by one bidder, Triple 7 Manpower Services, Inc.;

WHEREAS, on the said date the Committee declared Triple 7 Manpower Services, Inc. as the Single Calculated Bidder and directed the BAC- Technical Working Group (BAC-TWG) to conduct a Post-Qualification on the bid of Triple 7 Manpower Services, Inc.;

WHEREAS, the BAC-TWG submitted its Post-Qualification Report on 26 November 2019 with the following findings:¹

"xxx the Company passed the legal, technical and financial requirements for the post qualification process in the procurement of Janitorial Services for FY 2020 ."

WHEREAS, after due deliberation, the Committee adopted the findings and recommendation of the BAC-TWG;

WHEREFORE, the Committee **RESOLVES** as it hereby **RESOLVED** to **DECLARE** Triple 7 Manpower Services, Inc. as the Single Calculated and Responsive


