**DECLARATION OF FIRST FAILURE OF BIDDING FOR THE
PROCUREMENT OF JANITORIAL SERVICES FY 2024**

WHEREAS, the project "**Procurement of Janitorial Services FY 2024**" is included in the approved Indicative Annual Procurement Plan 2024 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Five Million Two Hundred Fifty-Eight Thousand Pesos (Php5,258,000.00)**;

WHEREAS, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) website and NLRC website from 22 November 2023 to 11 December 2023;

WHEREAS, the Pre-Bid Conference held on **29 November 2023** was attended by Triple 7 Manpower Services, Inc.;

WHEREAS, during the scheduled submission and opening of bids on 11 December 2023, Triple 7 Manpower Services, Inc. participated as the lone bidder;

WHEREAS, in a Resolution dated 11 December 2023, the Bids and Awards Committee (BAC) declared Triple 7 Manpower Services, Inc. as the Single Calculated Bid and directed the BAC Technical Working Group (BAC-TWG) to conduct Post-Qualification Process;

WHEREAS, in the Post-Qualification Report of the BAC-TWG dated 22 December 2023, the BAC-TWG recommended the following, to wit:

1. *To declare the Company to be post-disqualified for failure to submit its latest/valid Tax Clearance within the prescribed period in line with Section 34.2 of the 2016 Revised IRR of RA No. 9184; and*

2. To declare the bidding for the Procurement of Janitorial Services for FY 2024 a "failure" pursuant to Section 35.1 (c) of the 2016 Revised IRR of RA 9184

WHEREAS, Section 35.1 (c), Rule X of the 2016 Revised IRR of RA No. 9184 provides for the authority of the BAC to declare a failure of bidding when all bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation;

WHEREAS, as a result of the failure of bid , the end-user is instructed to conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2, Rule X of the 2016 RIRR of R.A. 9184;

NOW, WHEREFORE, in consideration of the foregoing, the Committee hereby **RESOLVES TO DECLARE** the First Failure of Bidding for the project "**Procurement of Janitorial Services FY 2024**" pursuant to Section 35.1 (c) of the 2016 Revised IRR of R.A. 9184.


