**DECLARATION OF FIRST FAILURE OF BIDDING FOR THE
PROCUREMENT OF SECURITY SERVICES FY 2023**

WHEREAS, the project "**Procurement of Security Services FY 2023**" is included in the approved Indicative Annual Procurement Plan 2023 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of ***Eight Million Three Hundred Thousand Four Hundred One Pesos and 94/100 (Php 8,300,401.94)***

WHEREAS, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) and NLRC Website from 11 November 2022 to 5 December 2022;

WHEREAS, the Pre-bid Conference held on 23 November 2022 was attended by **168 Security Services Inc. and Hackett Security Agency**;

WHEREAS, the opening of bids for the Procurement of Janitorial Services FY 2023 was conducted on 05 December 2022 and participated in by **168 Security Services Inc.**;

WHEREAS, the sole bidder submitted its bid price¹ amounting to **Nine Million Seven Hundred Thirty One Thousand Eighty Two Pesos and 93/100 (Php 9,731,082.92)** which is beyond the Approved Budget for the Contract for this procurement project;

WHEREAS, after due deliberation members of the NLRC Bids and Awards Committee declared 168 Security Services Inc. ineligible pursuant to **Section 35.1 (b) of the 2016 Revised IRR of RA No. 9184**;

NOW WHEREFORE, in consideration of the foregoing, the Committee **RESOLVES** as it hereby **RESOLVED** to **TO DECLARE** the first failure of bidding for
