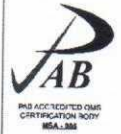

**DECLARATION OF THE BID OF TELCOM LIVE CONTENT INC. AS
THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR
THE PROCUREMENT OF CLOUD SERVICES SUBSCRIPTION, WEB
HOSTING WITH BACK-UP SERVER AND MAINTENANCE SERVICES FY
2023 AND RECOMMENDATION TO AWARD THE CONTRACT TO
TELCOM LIVE CONTENT INC.**

WHEREAS, the project "**Procurement of Cloud Services Subscription, Web Hosting with Back-up Server and Maintenance Services FY 2023**" is included in the approved Indicative Annual Procurement Plan 2022 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **One Million Pesos (Php1,000,000.00)**;

WHEREAS, the submission and opening of bids was conducted on 25 October 2022 and participated in by **My Creative Panda Web Design and Development Consultancy Services, Moodlelearning Inc., Telcom Live Content Inc., and My Busy Bee**;

WHEREAS, on the said date the Committee pronounced **Telcom Live Content Inc.** as the Lowest Calculated Bidder and directed the BAC- Technical Working Group (BAC-TWG) to conduct Post-Qualification Process on the bid of **Telcom Live Content Inc.**¹;

WHEREAS, during the meeting, the BAC-TWG presented its Post-Qualification Report dated 08 November 2022 with the following findings:²

WHEREAS, during the meeting, the end-user representatives submitted their Inspection Report dated 07 November 2022 manifesting that **Telcom Live Content Inc.** meets the technical specifications required by the project.³

NOW WHEREFORE, in consideration of the foregoing, the Committee **RESOLVES** as it hereby **RESOLVED** to **APPROVE** the findings of the BAC-TWG and to **DECLARE** the bid of **Telcom Live Content Inc.** as the Lowest Calculated and Responsive Bid for the Procurement of Cloud Services Subscription, Web Hosting with Back-up Server and Maintenance Services FY 2023;

RESOLVED FURTHER, to **RECOMMEND** to Chairman Gerardo C. Nograles the **AWARD** of contract to **Telcom Live Content Inc.**, subject to approval of the General Appropriations Act FY 2023.


