BAC Resolution No. 2025-01-05

APPROVAL OF THE 2025 NLRC ANNUAL PROCUREMENT PLAN (NON-CSE)

WHEREAS, Section 7.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act," states that no procurement shall be undertaken unless it is in accordance with the approved Annual Procurement Plan (APP), including the approved changes thereto;

WHEREAS, the General Appropriations Act (GAA) FY 2025¹ was duly signed and approved by President Ferdinand R. Marcos, Jr. on 30 December 2024;

WHEREAS, Section 7.3 of the 2016 Revised IRR of R.A. No. 9184 states that as soon as the GAA becomes final, the end-user or implementing units shall revise and adjust the PPMPs to reflect the budgetary allocation for their respective PAPs. The revised PPMPs shall be submitted to the BAC, through its Secretariat, for final recommendation of the methods of procurement;

WHEREAS, from the same provision, the indicative APP shall then be revised and approved in accordance with Section 7.2 of the Revised IRR of R.A. No. 9184;

WHEREAS, the APP shall be submitted to the GPPB on or before 31 January 2025, and shall be posted in accordance with E.O. 662, Series of 2007, as amended;



WHEREAS, the APP contained the final list of procurement projects that will be procured for the NLRC Central Office and all its Regional Arbitration Branches (RABs); the Procurement Management Office (PMO)/end-user/implementing unit; the method of procurement to use; the schedule of identified procurement activities as reflected in the APP form; the source of funds; the final ABC for each project; and other important details about the procurement projects;

WHEREAS, after due deliberation, the Committee **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Head of the Procuring Entity the **APPROVAL** of the herein attached 2025 Annual Procurement Plan (Non-CSE).
