

**WHEREAS**, the Procuring Entity invited Bids and has accepted a Bid by the Supplier for the **Procurement of Supply, Installation, Commissioning and Testing of Internet Services (1 Lot-Direct)** in the sum of **ONE MILLION SEVEN HUNDRED THIRTY-SIX THOUSAND THREE HUNDRED FIFTY-SEVEN PESOS & 04/100 (Php 1,736,357.04)**






