**DECLARATION OF FIRST FAILURE OF BIDDING FOR THE
PROCUREMENT OF ICT EQUIPMENT FY 2024**

WHEREAS, the project "**Procurement of ICT Equipment FY 2024 [PB 01-2024]**" is included in the approved Indicative Annual Procurement Plan 2024 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Eleven Million Three Hundred Ninety Eight Thousand Pesos (Php 11,398,000.00)**, with details as follows:

- a. Lot 1: **Procurement of 54 Units Laptop Computers With Operating System and Office Productivity Suite for FY 2024**, the sum of Two million Seven Hundred Thousand Pesos **(Php2,700,000.00)**;
- b. Lot 2: **Procurement of 5 Units High-End Computers Without Operating System for FY 2024**, the sum of Three Hundred Seventy-Three Thousand Pesos Only **(Php373,000.00)** and
- c. Lot 3: **Procurement of 185 Units Mid-Range Desktop Computers with Operating System and Office Productivity Suite for FY 2024**, the sum of Eight Million Three Hundred Twenty-Five Thousand Pesos Only **(Php8,325,000.00)**.

WHEREAS, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) and NLRC Website from 5 October 2023 to 31 October 2023;

WHEREAS, the Pre-Bid Conference held on 17 October 2023 was attended by Joneco Tech Corp., Masangkay Computer Center, Apex Office Supplies and Equipment Trading and Remax International Inc.;

WHEREAS, during the scheduled submission and opening of bids on 31 October 2023, no bid was received;


WHEREAS, Section 35.1 (a), Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A) No. 9184 provides for the authority of the BAC to declare a failure of bidding when no bids are received;

WHEREAS, as a result of the failure of bids, the end-user is instructed to conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates, pursuant to Section 35.2, Rule X of the 2016 RIRR of R.A. 9184;

NOW, WHEREFORE, in consideration of the foregoing, the Committee hereby **RESOLVES TO DECLARE** the First Failure of Bidding for the project **"Procurement of ICT Equipment FY 2024 [PB 01-2024]"** pursuant to Section 35.1 of the 2016 RIRR of R.A. 9184.


