



Contract for the Procurement of Janitorial Services for FY 2021

NATIONAL LABOR RELATIONS COMMISSION with address Ben-lor I.T. Center, 1184, Quezon Avenue, Quezon City herein represented by **HON. GERARDO C. NOGRALES**, Chairman, NLRC, and hereinafter referred to as the "Procuring Entity",

-and-

The **TRIPLE 7 MANPOWER SERVICES, INC.** with address Room Mezzanine Floor, Cavite Coliseum, Aguinaldo Hi-way, Bacoor City Cavite herein represented by its President, **MR. LAMBERTO G. MERCADO** and hereinafter referred to as the "Supplier"; collectively, the "Parties".

WHEREAS, the Procuring Entity invited Bids for the **Procurement of Janitorial Services for FY 2021** with an Approved Budget for the Contract (ABC) in the sum of FOUR MILLION EIGHTY-THREE THOUSAND PESOS (Php 4,083,000.00) inclusive of twelve percent (12%) Valued-Added Tax and other applicable Philippine government taxes;


WHEREAS, the Procuring Entity invited Bids and has accepted a Bid by the Supplier for the **Procurement of Janitorial Services for FY 2021** in the sum of **THREE MILLION TWO HUNDRED FIFTY-EIGHT THOUSAND FIVE HUNDRED FIFTY-THREE PESOS & 68/100 (Php 3,258,553.68)**

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

1. In this CONTRACT, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this CONTRACT, viz.:
 - a) Bidding Documents;
 - b) Winning bidder's bid, including the Technical and Financial Proposal, and all other documents/statements submitted by the Supplier;
 - c) Technical Specifications and Terms of Reference;
 - d) General Conditions of the Contract (GCC);
 - e) Special Conditions of the Contract (SCC);




- f) NLRC Bids and Awards Committee (BAC) Resolution No. 02-01, Series of 2021;

The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contact.




