



**Contract for the Procurement of Supply, Installation, Commissioning and Testing of Direct Internet Services FY 2024 (LOT 1)**

THIS CONTRACT made on the \_\_\_\_\_ day of SEP 13 2024 2024 in CITY OF MANILA, Philippines, by and between:

**NATIONAL LABOR RELATIONS COMMISSION** with office address at Ben-Lor I.T. Center, 1184, Quezon Avenue, Quezon City, herein represented by **HON. GRACE E. MANQUIZ-TAN**, Chairperson, NLRC, (hereinafter called "the Procuring Entity"),

-and-

**PHILIPPINE GLOBAL COMMUNICATIONS, INC.** with office address at 8755 PhilCom Building, Paseo De Roxas, Makati City, herein represented by its Business Development Group Head, **MS. KRISTINE D. GAMBOA**, (hereinafter called "the Supplier");


WHEREAS, the Procuring Entity invited Bids for the **Procurement of Supply, Installation, Commissioning and Testing of Direct Internet Services FY 2024 (LOT 1)** with an Approved Budget for the Contract (ABC) in the sum of ONE MILLION FIVE HUNDRED THOUSAND PESOS (Php1,500,000.00) inclusive of twelve percent (12%) Value-Added Tax and other applicable Philippine government taxes;

WHEREAS, the Procuring Entity invited Bids, and has accepted a Bid by the Supplier for the **Procurement of Supply, Installation, Commissioning and Testing of Direct Internet Services FY 2024 (LOT 1)** in the sum of **ONE MILLION ONE HUNDRED TEN THOUSAND PESOS ONLY (Php1,110,000.00)**.

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Contract Agreement, viz.:

E) Notice of Award of Contract; and the Bidder's *conforme* thereto; and

F) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **ONE MILLION ONE HUNDRED TEN THOUSAND PESOS (Php1,110,000.00)** or such other sums as may be ascertained, the Supplier agrees to supply, install, commission and test direct internet service.
4. The Procuring Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
