**DECLARATION OF TRIPLE 7 MANPOWER SERVICES INC. AS HAVING  
THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) FOR THE  
PROCUREMENT OF JANITORIAL SERVICES FY 2022**

**WHEREAS**, the project "**PROCUREMENT OF JANITORIAL SERVICES FY 2022**" is included in the approved Indicative Annual Procurement Plan 2022 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Two Million Pesos (Php 4,200,000.00)**;

**WHEREAS**, the submission and opening of bids was conducted on 14 December 2021 and participated in by **Triple 7 Manpower Services Inc.**;

**WHEREAS**, on the said date the Committee pronounced **Triple 7 Manpower Services Inc.** as the Single Calculated Bidder and directed the BAC-Technical Working Group (BAC-TWG) to conduct Post-Qualification Process on the bid of **Triple 7 Manpower Services Inc.**;<sup>1</sup>;

**WHEREAS**, the BAC-TWG submitted its Post-Qualification Report on 21 December 2021 with the following findings:<sup>2</sup>

*the Company passed the legal, technical and financial requirements for the post qualification process in the Procurement of Janitorial Services FY 2021"*

**NOW WHEREFORE**, in consideration of the foregoing, the Committee **RESOLVES** as it hereby **RESOLVED** to **APPROVE** the findings of the TWG and to **DECLARE** the bid of **Triple 7 Manpower Services Inc.** as having the Single Calculated and Responsive Bid for the Procurement of Janitorial Services FY 2022.






