Philippines, by and between:

WHEREAS, the Procuring Entity invited Bids, and has accepted a Bid by the Supplier for the **Procurement of ICT Equipment-for FY 2024 (2<sup>nd</sup> Bidding) Lot 1 — 54 Units Laptop Computers with Operating System and Office Productivity Suite** in the sum of **TWO MILLION ONE HUNDRED TWENTY-SEVEN THOUSAND SIX HUNDRED PESOS ONLY (Php2,127,600.00)**.


NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Contract Agreement, viz.:

  - ii. Technical Specifications;
  - iii. General and Special Conditions of Contract;
  - iv. NLRC Bids and Awards Committee (BAC) Resolution No. 2024-04-02 and
  - v. Supplemental Bid Bulletin No. 1

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **TWO MILLION ONE HUNDRED TWENTY-SEVEN THOUSAND SIX HUNDRED PESOS ONLY (Php2,127,600.00)** or such other sums as may be ascertained, the Supplier agrees to cause the delivery of 54 Units Laptop Computers with Operating System and Office Productivity Suite.

4. The Procuring Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


