WHEREAS, the project "**Procurement of Courier Services (May to December 2021)**" is included in the approved Annual Procurement Plan 2021 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of ***Eight Million Six Thousand Pesos (Php 8,600,000.00)***;

WHEREAS, the submission and opening of bids was conducted on 16 April 2021 and participated in by Airspeed International Corporation and 2GO Express Inc.;

WHEREAS, on the said date the Bids and Awards Committee (BAC) pronounced Airspeed International Corporation as the Single Calculated Bidder and directed the BAC- Technical Working Group (BAC-TWG) to conduct Post-Qualification Process on the bid of Airspeed International Corporation¹;




