**BAC Resolution No. 2024-11-01**

**RECOMMENDING THE AWARD OF THE CONTRACT TO TOYOTA  
FAIRVIEW, INC. FOR THE PROCUREMENT OF ONE (1)-UNIT  
PASSENGER VAN THROUGH NEGOTIATED PROCUREMENT DUE TO  
TWO FAILED BIDDINGS**

**WHEREAS**, the project **PROCUREMENT OF TRANSPORTATION EQUIPMENT FY 2024** (Lot 1 – 1 Unit Van) is included in the approved Indicative Annual Procurement Plan for FY 2024 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of One Million Four Hundred Fifty Thousand Pesos (₱1,450,000.00);

**WHEREAS**, the Bids and Awards Committee (BAC) declared a failure of the first bidding through BAC Resolution No. 2023-11-05 dated 8 November 2023 since no bids were received;

**WHEREAS**, the BAC again declared the failure of the second bidding with an increased ABC of One Million Seven Hundred Fifty Thousand Pesos (₱1,750,000.00) through BAC Resolution No. 2024-05-01 dated 8 May 2024 since no bids were received;

**WHEREAS**, the BAC resolved to change the procurement method from competitive bidding to negotiated procurement through BAC Resolution No. 2024-05-01 due to the failure of the two competitive biddings;

**WHEREAS**, the BAC resolved to delegate the conduct of the negotiated procurement for the Project to the Administrative Department (General Administrative Services) to expedite the procurement process;

**WHEREAS**, the BAC reflected the increased ABC of **One Million Nine Hundred Fifty Thousand Pesos (₱1,950,000.00)** in the Supplemental Annual Procurement Plan for the Second Semester of FY 2024;

**WHEREAS**, the Administrative Department (General Administrative Services) posted from 5 June 2024 to 14 June 2024 the procurement opportunity on the PhilGEPS and NLRC websites and in conspicuous places;

**WHEREAS**, the Administrative Department (General Administrative Services) certified on 28 June 2024 that no bids were received during the posting period;

**WHEREAS**, the Administrative Department (General Administrative Services) resorted to an open canvass approach due to the urgent need for the 1-unit van;

**WHEREAS**, the Administrative Department (General Administrative Services) presented to the Bids and Awards Committee on 13 November 2023 the Abstract of Canvass, viz:

Toyota Fairview, Inc.	One Million Eight Hundred Eighty Six Thousand Nine Hundred Forty Pesos Only (P1,886,940.00)
Nissan Commonwealth, Inc.	Two Million Pesos Only (P2,000,000.00)
Toyota San Jose Del Monte, Bulacan	One Million Nine Hundred Ten Thousand and Forty Pesos Only (P1,910,040.00)

**WHEREAS**, the BAC declared Toyota Fairview, Inc. as the lowest bidder after verifying and validating its quotation and determining that it passed all the criteria and requirements of the Procuring Entity;

**NOW, WHEREFORE**, the BAC **RESOLVES** as it hereby **RESOLVED** to **DECLARE** the bid submitted by **TOYOTA FAIRVIEW, INC.** as the Lowest Calculated and Responsive Bid and to **RECOMMEND** the award of the contract.

**RESOLVED**, this 13 November 2024 at the National Labor Relations Commission, Ben-Lor IT Center, 1184 Quezon Avenue, Barangay Paligsahan, Quezon City.


