**DECLARATION OF NUNTIUS ELECTRONICS, INC. HAVING THE
LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR THE
PROCUREMENT OF SUPPLY OF 70 UNITS LAPTOP COMPUTERS
WITH OPERATING SYSTEM AND OFFICE PRODUCTIVITY SUITE FY
2024 AND RECOMMENDATION TO AWARD THE CONTRACT**

WHEREAS, the project "**Supply of 70 Units Laptop Computers with Operating System and Office Productivity Suite FY 2024**" is included in the approved Annual Procurement Plan 2024 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Two Million Four Hundred Fifty Thousand Pesos (Php 2,450,000.00)** under **one (1) lot**;

WHEREAS, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) website and NLRC website from 29 February 2024 to 20 March 2024;

WHEREAS, in response to the advertisements, (1) Nuntius Electronics Inc. and (2) Joneco Tech Marketing Corp. submitted their eligibility documents on 20 March 2024, which was the deadline for the Submission and Opening of Eligibility Documents;

WHEREAS, after deliberation, the BAC pronounced **Nuntius Electronics Inc.** as the Lowest Calculated Bidder¹, with a bid price of Two Million One Hundred Thousand Pesos (Php 2,100,000.00), and directed the Technical Working Group (TWG) to conduct a Post-Qualification Process on the said bidder;

WHEREAS, after examination, validation, and verification of all the legal, technical, and financial documents submitted by **Nuntius Electronics Inc.**, the BAC, together with the TWG, determined, pursuant to its Post-Qualification Report dated 1 April 2024², that the bid submitted by Nuntius Electronics Inc. for the said lot passed the criteria for post-qualification and was found to be responsive to the requirements of the project.

NOW, WHEREFORE, in consideration of the foregoing, the BAC **RESOLVES** as it hereby **RESOLVED** to **DECLARE** the bid submitted by **NUNTIUS ELECTRONICS**
