Relative to the bidding for the procurement of Supply, Installation, Commissioning and Testing of two (2) separate 60 Mbps Direct Internet Services for CY 2020, please be informed that the Contract with existing internet provider (PLDT) for 60 MBPS of the NLRC Central Office will expire in October 2020 and some modification on the technical specifications with regards to the supply of routers. With the newly installed owned routers at NLRC- NCR, Bookman Bldg., supply of routers for the subsequent bidding for this services is no longer necessary, which may have a significant effect in terms of costing in the financial bid.
