

WHEREAS, the Procuring Entity invited Bids and has accepted a Bid by the Supplier for the **Procurement of Security Services for FY 2020** in the sum of **NINE MILLION TWO HUNDRED NINETY TWO THOUSAND THREE HUNDRED FORTY FOUR PESOS AND NINE CENTAVOS 09/100 (P9,292,344.09)**.




