**DECLARATION OF LBC EXPRESS, INC. HAVING THE LOWEST  
 CALCULATED BID (LCB) FOR THE PROCUREMENT OF COURIER  
 SERVICES FY 2025 AND CONDUCT OF THE POST-QUALIFICATION  
 PROCESS BY THE TECHNICAL WORKING GROUP**

**WHEREAS**, the project "**Procurement of Courier Services FY 2025**" is included in the approved Indicative Annual Procurement Plan for FY 2025 of the National Labor Relations Commission (NLRC) with an Approved Budget for the Contract (ABC) of **Thirteen Million Pesos (P 13,000,000.00)**;

**WHEREAS**, the NLRC advertised the Invitation to Bid for the abovementioned project at the Philippine Government E-Procurement System (PhilGEPS) and NLRC website from 29 October 2024 to 18 November 2024;

**WHEREAS**, the Pre-Bid Conference held on 06 November 2024 was attended by LBC Express, Inc., RAF International Forwarding Phils. Inc., Ximex Delivery Express, Inc., 2GO Express, Inc., JRS Express, and Radenta Technologies Inc.;

**WHEREAS**, in response to the advertisements, **LBC Express, Inc.** and **2GO Express, Inc.** submitted their eligibility documents on 18 November 2024, which was the deadline for the Submission and Opening of Eligibility Documents;

**WHEREAS**, upon evaluation, the Bids and Awards Committee (BAC) declared that both LBC Express, Inc. and 2GO Express, Inc. have successfully met the Eligibility, Technical and Financial requirements<sup>1</sup>;

**WHEREAS**, the aforementioned bidders submitted their bid prices as follows<sup>2</sup>:




